- 3. Engineer's Report—Jason Brenneman
  - 2023 Street Work
    - High Street decided earlier this year that until Cloverfield work is completed, High Street should not be paved. I do not see Cloverfield being completed by the end of 2023 paving season. Due to the amount of base repair on High Street, it might be getting close to be more cost feasible to do full depth reclamation like we did on Charles.
    - George Street decided this year that until all work is completed on George Street townhouses, repaving should not happen until 2<sup>nd</sup> building has been completed; 2<sup>nd</sup> building has not started. George Street requires full depth reclamation along with 5 curb ramp replacements.
    - Other streets for possible work include:
      - Springwood (settlement and some possible spot patches)
      - o Ice House & Katie (fabric and overlay plus bring handicap ramps up to spec which is required when paving streets (7 curb ramps to be updated or installed new)...this work is recommended before they get too bad creating more costly work)
      - East PA (will take a lot of work and a rebuild with curb/sidewalk and updated ADA ramps).

## Borough Storm Sewer Map & Analyzation

- Does Borough Council want to move forward with inspection of inlets and pipes on George, Springwood, Ice House, Katie, E. PA,
- Craig confirmed formal bidding would not be required and wage rates are not applicable since maintenance.
- **26 W. PA Avenue--**Storm sewer pipe within Borough's right-of-way. Property owner will be in attendance to discuss.
- **Stoltzfus Plan Review-**-Received revised plans and still do not recommend Council to conditionally approve the plan. Too many comments remain outstanding. Refer to our latest review letter attached.
- High Street Inlet Replacement--Still did not hear back from Aaron Manifold
- Hotel Land Development Plan--Developer still working on conditions
