ORDINANCE NO. 2005-05

AN ORDINANCE AMENDING SECTION 7 OF ORDINANCE NO. 2004-002 BY  
PRESCRIBING PENALTIES AND EXEMPTIONS FOR THE VIOLATION OF SNOW  
EMERGENCY PLAN-PHASE 1

---

BE IT ORDAINED AND ENACTED, by the Stewartstown Borough Council,  
Stewartstown Borough, York County, Pennsylvania as follows:

**SECTION 1:** Section 7 of Ordinance 2004-002 shall be amended and shall read as follows:

**“Section 7. Snow Emergency Plan – Phase 1**

- a. No parking on existing Borough streets including state roads and streets dedicated to public use including those not yet adopted by the Borough Council. All vehicles operated on streets must have either snow tires, chains/cables or all weather tires.
- b. All police, fire, ambulance and emergency vehicles are exempt from this exclusion. Personnel in personal vehicles are also exempt as long as they are traveling to and from in due course with the provisions associated with the police, fire, ambulance, and other emergency vehicles.
- c. Any vehicle parked or abandoned or otherwise left on a Borough street in violation of the Snow Emergency Plan Phase 1, shall be towed to a spot designated by the Borough. All charges for towing and storage shall be the responsibility of the vehicle owner.
- d. Any person who shall operate a motor vehicle in violation of the Snow Emergency Plan Phase 1 shall upon conviction thereof be sentenced to pay a fine of fifty (\$50.00) dollars and in default of payment be subject to imprisonment for a term not to exceed ten (10) days.”

**SECTION 2:** The passage of this Ordinance shall not be deemed to invalidate or repeal any provisions of the said Ordinance Sections except as specifically provided herein.

**SECTION 3:** If any section or provision of this Ordinance be declared by the Courts to be unconstitutional or invalid, such decisions shall not effect the validity of the Ordinance as a whole or any part thereof other than the part so declared to be unconstitutional or invalid.

**SECTION 4:** This Ordinance shall be effective five (5) days after its enactment by the Borough Council of Stewartstown Borough, County of York, Commonwealth of Pennsylvania.
